Item B2: 2846 - Kogarah Local Government Area - ANZAC Marches

**Author:** Andrew Sharp - Director Assets and Services (PC)

**Reason for report:** To consider the temporary closure of various roads in the Kogarah

Local Government Area (LGA) for ANZAC marches.

#### **Recommendation:**

a) That approval be granted to temporarily close streets on the Oatley RSL Sub-Branch ANZAC march route from 1.45pm on Sunday, 17 April 2016, in accordance with the details outlined in paragraph 3 of the report and as shown on plan L566 attached to the report.

- b) That approval be granted to temporarily close streets on the South Hurstville RSL Sub-Branch ANZAC march route from 5:30am on Monday, 25 April 2016, in accordance with the details outlined in paragraph 4 of the report and as shown on plan L567 attached to the report.
- c) That approval be granted to temporarily close streets on the Kogarah RSL Sub-Branch ANZAC march route from 7:15am on Monday, 25 April 2016, in accordance with the details outlined in paragraph 5 of the report and as shown on plan L568 attached to the report.
- d) That the RSL Sub-Branches be advised of Council's decision.

# Background

- 1. Requests have been received from representatives of Oatley RSL Sub-Branch, South Hurstville RSL Sub-Branch and Kogarah RSL Sub-Branch for approval to temporarily close various roads near the RSL Clubs in order to hold their ANZAC marches during April 2016.
- 2. Each RSL Sub-Branch has provided Council with the commencement times and proposed routes of their respective marches and these are detailed in paragraphs 3, 4 and 5 below.

### **Oatley RSL Sub-Branch March**

3. At approximately 1:45pm on Sunday, 17 April 2016, Oatley RSL Sub-Branch will be conducting a march commencing adjacent to the Oatley RSL Club on Letitia Street, Oatley. Those marching will then turn left into Frederick Street and proceed to the Oatley Memorial Gardens. The march is expected to take fifteen minutes.

#### **South Hurstville RSL Sub-Branch March**

4. At approximately 5:30am on Monday, 25 April 2016, South Hurstville RSL Sub-Branch will be conducting a march commencing in Resthaven Road, South Hurstville and then proceeding along Connells Point Road to the South Hurstville RSL Club. The march is expected to take thirty minutes and the ceremony will be held within the Club's off-street car park.

#### **Kogarah RSL Sub-Branch March**

5. At approximately 7:15am on Monday, 25 April 2016, Kogarah RSL Sub-Branch will be conducting a march commencing adjacent to the Kogarah RSL Club on Railway Parade, Kogarah. The marchers will turn left into English Street, and proceed to the Cenotaph on the corner of Park Street and English Street. A thirty minute service will be conducted at this location, after which the march will once again return along English Street, turn right into Bellevue Street, then left into Bowns Road and finally left into Railway Parade to conclude at the Kogarah RSL Club.

#### **Comments**


- 6. The RSL Clubs have requested the assistance of Kogarah SES and Hurstville SES to provide staff and man barricades to temporarily block the streets adjacent to the ANZAC march routes whilst their members are on the roadway. The RSL clubs have also requested and received confirmation from St George Police that they will be present to oversee the marches.
- 7. These events would be classified as a Class 4 Event according to the "Guide to Traffic and Transport Management for Special Events", and as such a Traffic Management Plan would not be required to be submitted to the Roads and Maritime Services (RMS) for approval prior to the events.

Item B3: 2847 - Marie Dodd Crescent, Blakehurst - Proposed "No

Parking" zone - UBD 313 P3

**Reason for report:** To consider the installation of a "No Parking" zone in Marie Dodd

Crescent, Blakehurst

#### **Recommendation:**

That a 37m "No Parking, 5am – 2pm, Wed" zone be installed on the western side of the bend in Marie Dodd Crescent, Blakehurst, between the driveways of No.'s 6 and 10 Marie Dodd Crescent.

#### **Background**

- 1. A request has been received to consider the installation of parking restrictions in Marie Dodd Crescent, Blakehurst, to assist with waste collection on this road.
- 2. Due to the narrowness of the carriageway and the number of vehicles parking on both sides of the street, waste contractors are having difficulty negotiating the bend along Marie Dodd Crescent, Blakehurst, and are required to make multiple visits to this location on waste collection day.
- 3. There is an existing "No Parking, 5am 2pm, Wed" zone at the end of the cul-de-sac to allow for waste contractors to turn their vehicles.

#### **Comments**


- 4. The installation of a "No Parking, 5am 2pm, Wed" zone on the bend in Marie Dodd Crescent, Blakehurst, between the driveways of No's 6 and 10 Marie Dodd Crescent, will stop vehicles from parking in this area on the waste collection days and lead to an improvement in vehicle turning movements and safety in this location.
- 5. The residents living in Marie Dodd Crescent have been consulted by letter of the proposed "No Parking" zones. Submissions on the proposal were invited to be submitted by 11 March 2016. No objections have been received.

6. Within budget allocation – RMS's Traffic Facility Grant – approximately \$600.

Item B4: 2848 - Ramsgate Road, Kogarah Bay - Proposed "Bus Zone" -

**UBD 294 E13**

**Reason for report:** To consider the installation of a "Bus Zone" on Ramsgate Road,

Kogarah Bay.

#### **Recommendation:**

That a 30m "Bus Zone" be installed on the southern side of Ramsgate Road, Kogarah Bay, at the bus stop adjacent to No. 9 Ramsgate Road, near the intersection of Park Road.

## **Background**

- 1. A request has been received from a resident to investigate issues relating to vehicles parking across the driveway at No. 7 Ramsgate Road, Kogarah Bay.
- 2. During an investigation by Council officers, it was observed that there is a bus stop (stop number 221717) adjacent to 9 Ramsgate Road. Vehicles were witnessed parking within the legally allowable distance to the bus stop, resulting in buses being unable to safely stop parallel to the kerb, causing a dangerous situation for drivers and bus commuters.
- 3. Transdev operates the Route 947 service from Kogarah to Hurstville via Ramsgate and Dolls Point stopping at Ramsgate Road. It is proposed to establish a formal "Bus Zone" on the southern side of Ramsgate Road, preventing parking in this location during the times that the 947 bus service operates.
- 4. The proposal referred to above has been endorsed by a representative of Transdev.

#### **Comments**

5. The installation of a formal "Bus Zone" on the southern side of Ramsgate Road, would prevent parking in this location during the times that the 947 bus service operates and would therefore lead to an improvement in safety for bus commuters.

6. Within budget allocation – RMS's Traffic Facility Grant – approximately \$250.

Item B5: 2849 - Neville Street, Oatley - Proposed Temporary Road Closure

for Oatley Scouts - UBD 293 C13

**Reason for report:** To consider a request for the temporary road closure of Neville Street,

Oatley.

#### **Recommendation:**

a) That approval be granted to temporarily close Neville Street, Oatley, from Oatley Parade to Oatley Avenue, between 6am and 5pm on Saturday, 4 June 2016, as shown on the Traffic Control Plan attached to the report.

b) That the President of the 1<sup>st</sup> Oatley Bay Sea Scouts be advised of Council's decision.

# Background

- 1. A request has been received from the President of the 1<sup>st</sup> Oatley Bay Sea Scouts to conduct their annual community market day on Saturday, 4 June 2016. This request includes a proposal to temporarily close a section of Neville Street, between Oatley Parade and Oatley Avenue, Oatley.
- 2. This event has been occurring within Oatley Memorial Park for the past sixteen years and Council has previously supplied the barricades and road closure signage to the 1<sup>st</sup> Oatley Bay Sea Scouts for appropriately trained and qualified personnel to close Neville Street for the event.

## **Proposal**

- 3. It is proposed that Neville Street, between Oatley Parade and Oatley Avenue, be closed to vehicular traffic from 6am to 5pm on Saturday, 4 June 2016, to allow the safe movement of people attending the 1<sup>st</sup> Oatley Bay Sea Scouts annual community market day.
- 4. The event would be classified as a Class 3 Event according to the "Guide to Traffic and Transport Management for Special Events", and as such a Traffic Management Plan would not be required to be submitted to the Roads and Maritime Services (RMS) for approval prior to the event.

#### **Operational Plan Budget**

5. Within budget allocation – RMS's Traffic Facility Grant – approximately \$400.
